BHI is a multi-platform risk management system which has been designed and created by our in-house health and safety professionals and our IT development team in conjunction with our clients.

BHI delivers real time information to assist clients with the modern demands of legislative compliance by utilising the most up to date technology available. Our concept has always been to be the market leading online management system that records, manages and prompts compliance tasks across all Health and Safety disciplines.

BHI is delivered via a modular approach which ensures that each area of Health and Safety compliance is accurately assessed.

Modules available include:

- Health and Safety
- Fire
- Asbestos
- Legionella
- Accident Reporting
- Training

The system is typically purchased in conjunction with the provision of RPS consultancy services

Alternatively, for organisations who undertake their own assessments, the system can be provided on a standalone basis.

BHI also provides access to over 100 online forms which allows users to manage each specific compliance requirement. Forms include:

- COSHH
- DSE
- Manual Handling

The system provides the functionality to allow you to create bespoke assessments, tailoring the forms to meet individual business requirements.

Data is stored on the system as a result of risk assessments and audits, providing identified actions arising from non-conformities, which can then be addressed and recorded to create a robust audit trail.

Tasks can be simply completed at the click of a button and the data can be easily retrieved and interrogated. Data can also be exported or emailed to third parties for completion.

The reporting functionality enables sites or individuals to demonstrate their progress in achieving compliance with legislative standards and your company's internal policies.

Users are able to track tasks that are overdue and therefore prioritise expenditure and focus resource where required.

Statutory Inspections

Assets can be added within our asset reporting tool to ensure that all inspection/service dates are recorded and inspection due dates (e.g. lift inspections) can be easily identified. This provides live asset data and information on compliance to allow effective asset management.

Company Documentation

All risk management data can be easily and safely stored in the documentation storage section which provides guaranteed document control, vital for all risk management systems. Data can be uploaded by contractors as well as staff within your organisation. This would include, for example, statutory inspection certification.

BHI INTERACTIVE RISK MANAGEMENT Fire Module

The BHI Fire Module is a comprehensive tool that enables managers to maintain their fire risk assessment data with ease. The system enables you to make your fire risk assessment data available to authorised users in a user friendly environment.

BHI can be accessed from any PC, laptop, tablet or smartphone with an internet or data connection. Access rights and privileges are controlled by secure logins and standard security protocols.

Fire risk assessments completed through BHI are compliant with all LIK fire safety legislation

Action plans, monitoring regimes and training records support the risk assessments to give a comprehensive picture of compliance.

The system provides proactive alerts to support your management system and keep you in control at all times. The document management section allows users to attach and manage photographs, drawings and a range of documents relating to each of your properties.

BHI has the flexibility to support procurement processes following the undertaking of the fire risk assessment. For example, if the assessment identifies the need for a fire door replacement programme, access can simply be given to designated contractors enabling them to view the required work and provide a proposal.

Ensuring your business has an effective Asbestos Management Plan has never been as important as it is today. BHI's Asbestos Module allows you to store and pro-actively manage your asbestos liabilities at the touch of a button.

The Asbestos Module consists of a live asbestos register which can be updated as re-assessments, encapsulations and removals occur. Associated documents for these operations (e.g. air clearance Asbestos Regulations 2012. certificates) can be uploaded to the relevant locations or items. Priority assessment can be added by the user and updated when applicable.

Photographs can be linked to Asbestos entries via a CAD/PDF plan. Interactive image file plans can also take you to the associated entry for the area/room or sample selected.

All recommendations from the entries can be linked to task reminders for those who manage the asbestos within your buildings, which helps you meet your requirements under the Control of What can BHI do for me?

Legionella and Water Hygiene Module

BHI helps you to meet your Legionella and water hygiene legislative requirements through instant access to live information. Our UKAS accredited risk assessments ensure peace of mind regarding statutory compliance across your portfolio.

The BHI Legionella module is tailored to address the wide ranging types of water systems, with individual templates utilised for:

- Cooling Towers
- Domestic Hot and Cold Water Systems
- Other Risk Systems

Through structuring the system in this way it is very easy to interrogate BHI to determine compliance for specific water systems (e.g. cooling towers) providing peace of mind that these high risk systems are being correctly managed.

The management of water systems can, at times, involve a number of different parties. BHI allows access to be given to any number of stakeholders, including:

- · Water Treatment Contractors
- M&E Contractors
- FM Companies

All parties have the facility to upload information into the system which includes:

- Cleaning and Chlorination Certificates
- · Legionella Testing Certificates
- Photographs
- Water Treatment Service Sheets

Asset registers, produced during the process, provide the information required to develop site log books within BHI. The online log book provides immediate notification if a test is missed or if a test falls outside control parameters.

The accident reporting module is a simple and accessible package which allows end users to immediately report an accident or incident. Notifications can then be sent straight to your nominated responsible person via email, advising that a report has been logged.

The ability to provide root cause analysis and host witness statements and photographic evidence sets BHI among the market leaders in this field.

The system has the ability to report accidents by type, location and lost time in both quantitative and graphical representation. All data and graphs can be exported.
